WARNING

PRECAUTIONS

APPROVED HANDLER: Not required.

STORAGE: Store in original container, tightly closed and away from foodstuffs. Store in a cool dry well ventilated area, avoiding sunlight and temperatures below -5°C and above 35°C . When stored appropriately this product should show no significant degradation for two years from the date of manufacture. Contact your supplier for information about the use of product that is older than this.

PROTECTIVE CLOTHING: When mixing or applying this product, overalls, boots, gloves and eye protection should be worn.

SPRAYING EQUIPMENT: Apply only with well maintained and calibrated equipment.

PERSONAL HYGIENE: Do not eat, drink or smoke while using. Remove protective clothing and wash hands and face thoroughly before meals and after work.

TRACKING: This product does not need to be tracked.

RECORDS: Record keeping is not required when using this product.

PRODUCT DISPOSAL: Dispose of this product only by using according to the label directions or if this is not possible alternatively contact your supplier for advice.

CONTAINER DISPOSAL: Triple rinse container and add rinsate to the spray tank. Dispose at an approved landfill. Do not burn. Do not use container for any other purpose.

DIRECTIONS FOR USE

AGPRO Anti-foam 1410 works effectively in very low concentrations. One to 100 parts of active silicone per million parts water are sufficient to eliminate most foams. 20-50mls of 2eAGPRO Anti-foam 1410 per 100L of liquid is generally sufficient to eliminate or suppress the foam in most situations. Start with the higher rate and then reduce the addition rate to achieve the desired level of foam control.

MIXING

For best results pre-dilute the AGPRO Anti-foam 1410 with 5 parts water and add to the liquid. This helps dispersion. Pre-diluted material should all be used immediately. If the system can provide adequate dispersion the Anti-foam may be added directly without pre-dilution. It is best to add to agitated liquids before foam starts to appear, however it may be added after foaming occurs to break the foam.
