AGPRO Breakdown is a non-selective and non-residual herbicide that controls a wide range of annual and some perennial weeds in industrial/wasteland areas. **AGPRO Breakdown** works only on direct contact with foliage, causing rapid wilting of the leaves. The effect will be noticed within hours. AGPRO **Breakdown** is most effective on actively growing weeds and when applied in hot. sunny conditions. Do not use on pasture or cropland areas.

RAINFALL

Rainfall within 3 hours following treatment may reduce effectiveness. Farlier re-treatment should be considered following heavy rain.

DIRECTIONS FOR USE

Stir or mix well. Add the full quantity of the product to the partly filled spray tank whilst agitating. Fill tank and agitate to ensure thorough mixing and continue agitation while spraying. Agitate from the bottom if allowed to stand.
