## 4. FIRST - AID MEASURES

Ingestion If swallowed, do NOT induce vomiting. Rinse mouth with water. Contact the National Poisons Centre on 0800 POISON

Inhalation Remove patient to fresh air. Keep in position comfortable for breathing. If breathing is shallow or has stopped ensure airway

is clear, apply resuscitation and seek medical assistance immediately.

Skin contact Remove contaminated clothing and wash with soap and running water. If irritation or rash occurs, get medical advice.

Eye contact If in eyes flush with plenty of water holding eyelids open if necessary. Remove contact lenses if present, after a few minutes,

then continue flushing with water. Get medical advice if irritation persists.

Advice to Doctor No specific antidote. Treat symptomatically.

## 5. FIRE FIGHTING MEASURES

Flammability: Combustible liquid and vapour.

#### 6. ACCIDENTAL RELEASE MEASURES

Spills and Disposal: Eliminate or isolate sources of ignition. No smoking. Wear personal protective equipment. Exclude

non-essential people from the area. Stop leak if safe to do so. Contain spillage. Collect liquid into labelled containers than can be closed, for reuse or disposal. Absorb spills with inert material and place in a sealable labelled waste container. Dispose of waste safely in an approved landfill or hazardous waste

facility.

Environmental Precautions: Prevent from entering drains, waterways or sewers. If spill does enter waterways immediately contact

local authority. TRIFLAIN is a herbicide and spillage on soil may damage crops.

# 7. HANDLING AND STORAGE

Handling: Keep out of reach of children. Read label before use. Keep container tightly closed when not in use. Use only

according to label.

Wear personal protective equipment. Avoid contact with skin and eyes and inhalation of vapours or spray mist.

Contaminated work clothing should not be allowed out of the workplace. Use outdoors or in well-ventilated area.

Do not apply directly into or onto water. Take all reasonable steps to ensure the product does not cause any

significant adverse effects to the environment beyond the application area.

Written records of use are required if more than 3 kg (3L) applied within 24 hours in a place where the product is likely to enter air or water and leave the application area. TRIFLAIN must be under the control of a Qualified

Handler during use.

Storage: Signage, an emergency response plan and secondary containment are required when 100 L or more is on site.

Store in original container tightly closed and in a secure well-ventilated area avoiding flames, hot surfaces, direct

sunlight and away from foodstuffs, fertilisers and seeds.
